### **In the Matter of Honor the Earth's October 27, 2020 Petition for Investigation and Complaint Concerning the Capacity of the Enbridge Mainline System**

**Comment Period:** Enbridge Answer to Honor the Earth by **Wednesday, November 25, 2020**  
Replies to Enbridge's Answer by **Tuesday, December 15, 2020**

#### **Topics Open for Comment:**

At this stage, the Minnesota Public Utilities Commission (Commission) will evaluate whether the filing has demonstrated that further investigation is warranted, and, if so, what procedures should be used to guide the process. Please focus your comments on the following topics:

- Does the Commission have jurisdiction over the issues raised in Honor the Earth's filing?
- Are there reasonable grounds to investigate the allegations related to Enbridge's Line 3, Line 4, and Line 67 pipelines?
- If there are reasonable grounds to investigate, what procedures should be applied to conduct the investigation or investigations?

**Background:** On October 27, 2020, Honor the Earth filed a Petition for Investigation and Complaint that requested the Commission: (1) open an investigation into Enbridge's Mainline System completed pipeline capacity additions from 2016 to 2020, its planned capacity additions for Lines 4 and 67, its planned capacity addition resulting from reversal of Line 13, and other possible planned pipeline capacity additions other than the Line 3 Pipeline Replacement Project; and (2) require Enbridge to seek recertification for its proposed capacity additions for Lines 4 and 67, and any other permitted pipelines for which the average annual capacity has increased by 10 percent or more.

**Filing Requirements:** Utilities, telecommunications carriers, official parties, and state agencies are required to file documents using the Commission’s electronic filing system (eFiling).
